## **Press Release** **Operation Spring Cleaning**

On 3/20/14, The CNET Drug Taskforce and the Bates County Sheriff's Office concluded a several month long narcotics investigation. Extra officers had been brought in to serve arrest warrants on suspects from the investigation.
